Daniel Warner

Of US and Swiss citizenship, Daniel Warner earned his BA in Philosophy and Religion with honors from Amherst College, USA, and a PhD in Political Science from the Graduate Institute of International Studies in Geneva, Switzerland. His thesis and later book *An Ethic of Responsibility in International Relations* was awarded the Marie Schappler Prize by the *Société Académique de Genève* in 1991.

Dr. Warner has lectured and published extensively on multilateralism, US foreign policy, ethics, refugees, international law, international relations theory and security. Author, editor or co-editor of eleven books and numerous articles in refereed journals, his work has been translated into Arabic, Azeri, French, German, Persian and Russian. His chapters have appeared in The Sage Handbook of Human Rights, The Encyclopedia of Applied Ethics and The International Studies Association Encyclopedia.

Dr. Warner has lectured at Oxford, Cambridge, Harvard, Yale, Moscow State University, the University of Tokyo, Fudan University (Shanghai), Hebrew University, Fundacao Dom Cabral (Brazil), Nehru University (Delhi) and the University of Paris, Sorbonne, among other universities as well as in the public and private sectors and has been an invited scholar by Australian National University, University of Nebraska-Lincoln, the Ministry of Foreign Affairs of the Republic of China, the Japan Foundation and Oxford University.

Dr. Warner is a frequent commentator on television and radio throughout the world including the BBC, National Public Radio and Voice of America and his editorials have appeared in the *International Herald Tribune* and the *Financial Times*. He currently writes two blogs, one on general politics for *Tribune de Genève* and the other on the former Soviet Union for *nashagazeta.ch* as well as having written for the Associated Press. He was a regular commentator on the public station World Radio Switzerland for several years before it stopped broadcasting. He has served as an advisor to the ILO, UNHCR and NATO and been a consultant to the Ministries of Foreign Affairs and Defense of Switzerland and in the private sector.

Dr. Warner established the Program for the Study of International Organization(s) (PSIO) in 1994 at the Graduate Institute where he served for many years as the Deputy to the Director. The PSIO served as an interface between academics and policy-makers. Among its many activities, the PSIO organized training courses for young government officials from 27 countries in Eastern and Central Europe, Algeria, Burundi, the South Caucasus, Central Asia, Iran, Morocco, Tunisia

and the Former Yugoslavia. The PSIO grew into the Centre for International Governance (CIG) which organized training courses and support programs throughout the world including the Great Lakes region of Africa and Kosovo as well as multistakeholder facilitation activities in both the public and private sectors.

Since his retirement from the Graduate Institute in 2010, Dr. Warner has been the Assistant Director for International Affairs at the Geneva Centre for the Democratic Control of Armed Forces (DCAF), an international foundation established in 2000 on the initiative of the Swiss Confederation that contributes to enhancing security sector governance (SSG) through security sector reform (SSR) throughout the world.
